A TALE OF TWO KNEES ... AND TWO SUCCESSFUL SURGERIES

SHIRLEY SORENSON HAS TWO NEW KNEES AND ONE GREAT BIG SMILE.

For several years, Shirley suspected her troublesome left knee would eventually require surgery. But, after injuring her right knee while attempting to assist her husband who had fallen, delaying surgery was no longer an option. Now her injured right knee took precedence over her aching left knee.

In August of 2021, Dr. Andrew Pick, orthopedic surgeon with NW Iowa Bone, Joint & Sports Medicine of Spencer Hospital, performed a total knee replacement of Shirley's right knee. A few months later, in January 2022, Dr. Pick replaced Shirley's left knee.

Both surgeries were successful, with Shirley up and walking right after each procedure and experiencing great hospital stays. The only difference between right and left knee was that the second procedure was performed using robotic assistance technology.

"The orthopedic robot is a great addition to the Spencer Hospital Surgery Center," Dr. Pick commented. "This tool offers our surgeons another option when determining the best procedure for our individual patients. As surgeons we carefully evaluate each patient's condition and needs to determine which type of joint replacement procedure is the best fit for that patient."

Shirley was delighted with the results of both procedures. She encourages others who have experienced joint concerns, yet may be hesitant to take the next step, to consider scheduling a consultation with a specialist from NW lowa Bone, Joint & Sports Surgeons. "I feel great!" she exclaimed. "I was up walking the next day after both procedures, and driving a car soon after, possibly even a bit before it was recommended," she added with a mischievous smile.

In addition, to Dr. Pick, Dr. Jason Hough, Dr. Michael Dirkx and Dr. Christopher Rierson also offer joint replacement and a wide range of other orthopedic care and surgical services at Spencer Hospital. Warner Dialysis Centers

NOW OFFERING AT-HOME CARE IN ADDITION TO TREATMENT CENTERS IN SPENCER & SPIRIT LAKE

For nearly 30 years, people in northwest lowa in need of dialysis care could receive treatments close to home at Warner Dialysis Centers of Spencer Hospital, with centers located in Spencer and Spirit Lake. More recently, some dialysis patients have been able to obtain care in their homes, by opting for in-home dialysis treatments.

"It's wonderful that we're able to offer both options by providing dialysis treatments at our centers and also supporting patients who choose to undergo home dialysis," commented Danette Forbes, director of dialysis services. "We're partnering with Avera home dialysis services to offer this option to our patients locally. There are advantages to both services. An individual's health and personal preferences are big factors in determining the best option for each patient."

First, the similarities. The care and support team is the same whether a person receiving dialysis treatment is undergoing care within one of the Warner Dialysis Centers or at home. All patients have regular consultations with nephrologist Dr. Kevin Marquez and have care coordinated by the center's social worker, register dietitian and nursing team. In addition to monthly checks, the care team is a phone call away for athome patients when questions arise or assistance is needed. This same care team works closely with people who come to either of the local centers for dialysis treatment three times each week.

Forbes explained that people who undergo home dialysis have greater flexibility in deciding when to do their treatments. Also, those undergoing at-home care usually have fewer dietary restrictions as they are undergoing dialysis each day, rather than three times each week. At the Warner Dialysis Centers, a person's kidneys and blood supply are cleansed using hemodialysis, which is a process that uses an artificial kidney machine. For home dialysis, a person can use hemodialysis, yet most choose the peritoneal dialysis method, which uses a person's peritoneal cavity, which lines the abdomen inside the body, to help with the purification process.

"A patient who chooses home peritoneal dialysis typically run their treatments each day, at a minimum of eight hours and sometimes up to 12 hours," explained Lisa Wade, an Avera home dialysis nurse. She explained that many patients are able to do the home process overnight, sleeping and resting during that time-frame.

She added, "At home you have more control over when and where you will be doing your treatments. Patient autonomy is one big advantage, as home dialysis gives you back a

little control, allowing you to set your schedule and also, since you're dialyzing daily, you can enjoy a more liberal diet. However, some people appreciate the routine of in-center treatments and having the professional staff there to provide treatments and be accessible if complications arise." Fanny Maher of Spirit Lake really appreciates the home dialysis option.

"It is very convenient to be at home and choose my own schedule," Fanny said. Fanny does a dialysis treatment daily for a 12-hour period; however, she has flexibility in starting her treatment time.

"I can connect to the machine at 7 pm and spend time watching TV or playing games on my tablet. Then, I can go to sleep around 10 at night and shortly after I wake up the next morning, I can be done and have the whole day to do whatever we wish. Or, if we go to a party and get home late, I can start my treatment at 10 or 11 pm, and just go longer the next morning."

Fanny has experienced both types of treatment, starting her care approximately two years ago at Warner Dialysis Center in Spirit Lake, then switching to home dialysis approximately a year ago. She prefers the home treatments, yet continues to appreciate the support of the Warner Dialysis team through monthly check-ups. Also, she has a great care partner at home to help her with her care.

"I have a wonderful husband who does all the hooking up



on the machine, reading the numbers and helping with the supplies," she fondly said of her spouse Paulo, who tracks all her daily vitals and manages the inventory of supplies. The Mahers are very pleased with the support they receive from their healthcare team.

NEW CT SCANNER OFFERS ENHANCED TECHNOLOGY AND PATIENT COMFORT

BIGGER, BETTER, FASTER.

Spencer Hospital's new CT (computed tomography) scanner offers several advances in functionality, such as quicker scan times and higher resolution of images for greater clarity than the high-quality images produced by the previous scanner. The lateral slide table allows for easy repositioning of a patient. However, what many patients like best is that the opening to the scanner is larger, offering greater comfort for those receiving care.

"This CT scanner is the current top-of-the-line option," said Dr. Nathan Rohling of Midwest Radiology & Imaging. "As a radiologist, I appreciate the investment made in quality imaging equipment. I also value the training and skills of our technologists who capture excellent images," said Dr. Nathan Rohling of Midwest Radiology & Imaging.

Over 5,000 CT scans are performed annually at Spencer Hospital. Studies include scans of the brain, abdomen, pelvis, chest, lungs and extremities as well as procedures related to pain management and cardiac screening.

Spencer Hospital's diagnostic imaging services are accredited by the American College of Radiology in numerous modalities, including CT and CT Lung Cancer Screening. Additionally, Spencer's diagnostic imaging services are accredited in breast ultrasound, 3D mammography, stereotactic breast biopsy, ultrasound, MRI, nuclear medicine and PET (positron emission tomography) scanning. The imaging department is also recognized as a Breast Imaging Center of Excellence.

"We're proud to be the only imaging center in the region to be accredited in all of these modalities," expressed Mary Brosnahan, Diagnostic Imaging Services director. "Such accreditation means the hospital's imaging professionals and our protocols meet the highest levels of care and outcomes for our patients."

The new CT scanner, installation and room upgrades cost approximately \$680,000. A \$50,000 grant was awarded by USDA Rural Development, which was coordinated by the Spencer Regional Healthcare Foundation.

Convenient access to quality healthcare can also be lifesaving.

"I came into the clinic with severe chest pains. I was having a hard time talking and breathing. I knew I wouldn't make it to the hospital. Everybody there helped me an immense amount – they really made a difference." This comment came from a grateful patient after a recent visit to Sioux Rapids Family Care. He prefers not to share his name and draw attention to himself, yet he is so appreciative of his care. "Tell them thank you! Someday, when I'm feeling better, I'll walk down and tell them in person. I appreciate everything!"

The healthcare professionals at Sioux Rapids Family Care provide a wide range of primary care services, including treatment for injuries and illnesses, chronic health management, occupational health care, and preventative care.

Advanced registered nurse practitioner Kathi Heckert serves as the primary provider and is assisted by nurse Tracey Biedenfeld and ancillary service techs Cathy Whalen and Erin Rusk. Physical therapist Sara Goodchild cares for patients two to three days weekly, and occupational therapy services are arranged as needed.

"I appreciate getting to know my patients and feel like I can treat them more on a personal level," Heckert said. "I enjoy helping them improve their health and having a positive impact on their lives."

Heckert has served as an advanced registered nurse practitioner for 13 years, starting her career in Aberdeen, SD. In addition to primary clinic care, she's worked in collaboration with physicians specializing in occupational health, neurosurgery, and internal medicine.

Heckert explained that the clinic works closely with the healthcare professionals of Avera Medical Group Spencer and Spencer Hospital. "I usually refer patients to the specialists in Spencer, such as ear, nose and throat; orthopedics, gynecology, general surgery and urology. I also will refer to outreach specialists who travel to the area, such as cardiology, pulmonary and such, so patients don't have to travel far."

Specimens for lab tests are conveniently drawn in the clinic, and either analyzed locally or sent to the hospital laboratory for analysis. General imaging, such as lung scans or ankle x-rays, are also performed right at the clinic.

The benefits of a local clinic are many, including familiar faces, flexible scheduling and quick appointment scheduling, often with the ability to be seen the same day. Craig Cadman, who has been a patient at the clinic, commented: "I appreciate the fact that I got in so quickly. I called on one day and got an appointment for the next, which was awesome and, it fit my schedule. The staff was very friendly, very helpful and I appreciate that they listen."

Billings has over 17 years of experience in family medicine. She enjoys chronic health management, preventative care and acute care medicine. "As a family nurse practitioner, I believe in treating the whole person and working closely in context with their families," Billings commented. "Our office works and cares for people of all ages and backgrounds."

Billings said she and her staff work closely with the Avera Medical Group Spencer and Spencer Hospital medical teams to care for each patient's complete needs. When needed, Billings refers patients to specialists on the medical staff.

"We work closely with area medical professionals as a team to treat the whole person in providing whatever the patient needs for their best care," Billings stated. "We believe every person deserves to be treated with respect and be given high-quality care, and work together to identify each individual's health needs."

TOE NAIL CARE CLINIC OFFERS NAIL CARE AND FOOT HEALTH REASSURANCE



For others, the service is beneficial if they have difficulty bending or seeing clearly. Spencer Hospital's Wound Care Toe Nail Clinic offers effective toenail treatments to help heal their nails and provide greater comfort.

KNOWLEDGE IS A POWERFUL TOOL TOWARDS ACHIEVING YOUR OPTIMAL HEALTH. THE SPENCER REGIONAL HEALTHCARE FOUNDATION IS PLEASED TO HELP SUPPORT SPENCER HOSPITAL'S DIABETES EDUCATION TEAM BY FUNDING IMPORTANT EDUCATIONAL RESOURCES THAT PATIENTS CAN USE TO HELP MANAGE THEIR DIABETES.

Over 37 million Americans have diabetes, which can lead to a number of health complications, including cardiovascular disease, nerve damage, kidney failure, vision problems, and difficulty healing wounds.

The Foundation recently funded the purchase of a Dexcom G6 Pro, continuous glucose monitor which can be offered to patients who are interested in tracking their blood sugars more frequently. This device continuously monitors glucose levels through a small catheter inserted just underneath the skin, rather than poking one's finger multiple times per day.

This continuous glucose monitoring device allows patients to have readings of their blood sugar levels as often as every five minutes. This information can assist in making adjustments to their diet and activity to better manage their diabetes. Additionally, patients can share the results electronically with their health care provider so together they can see the trends and make decisions as to how to best manage care.

"It is so helpful for patients to see how their blood sugar reacts after eating specific foods or right after activity," commented Jeannette Hasley, director for Diabetes Education. "This type of information enables patients better



understand what they can do in the future and make adjustments to what their body needs."

The foundation also supports the Diabetes Education team by funding education kits for patients that have been diagnosed with diabetes. These kits contain several items, including:

- Glucose tablets, which are a quick way for someone with diabetes to increase low blood sugar levels;
- A mirror for individuals to use to check the soles of their feet for cuts or other injuries since nerve damage may cause numbness, making it harder to feel pain or discomfort from minor wounds;
- A portion plate, which provides a visual of how much of different types of food an individual should have at meal time;
- A "Calorie King" book, which is full of great information on references to calories, fats and carbohydrates;
- Lotion for healthy skin;
- Resistance bands for light exercise.

"Our diabetes education team teaches patients how to utilize each of these items so they can be actively engaged in their own health," Hasley said. "The tools we provide assist patients in learning how to actively monitor their diabetes and strive to prevent complications. The items in the kits are valuable in teaching healthy tips for self-care."

Hasley shared a recent comment from one of the team's patients, "I just wanted to let you know I have started the New Year out with success. You have no idea how much your phone call uplifted and supported me when I felt alone and abandoned. I have lowered my weight and blood sugar by eating proper portions, not eating between meals and not eating sugar. I know I have a long road ahead of me, yet my goals are important to me and I will work hard on them."


